**ORDER**

**Shri Samuel Perying**, is hereby engaged as Contractual Trained Graduate Teacher (TGT) Elementary on Contract basis in the fixed pay of Rs. 20000/- (Rupees Twenty Thousand) only. His salary will be drawn w.e.f. the date of joining in the concerned school where he is posted for the academic session / contract period 2020 - 21 against centrally sponsored scheme of ISSE : Samagra Shiksha. He is posted to **Govt. Hr. Sec. School, Bolung** under Roing Block. This appointment is made against the post vacated by Shri Ojing Ngukir.

Further extension of his engagement period will be subject to his satisfactory performance and continuation of the ISSE project by Ministry of Education (MoE), Govt. of India.

**The engagement is subject to the following conditions:-**

1. The contract teacher / employee have no right to claim for regular appointment / regularization of the post after expiry of contract employment.
2. Except casual leave no other leave is admissible as per norms.
3. During contract service period is not entitle of medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel for vacation period etc.
4. The second party shall be entitled for drawl of salary only for the academic session / contract period. Salaries for vacation period of teachers shall be drawn only when he is engaged in training, bridge course and any other departmental engagement.
5. His service period will be counted from the date of joining in the duties.
6. He is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract service.
7. The engaged Teacher is also to work as Volunteer instructor for TLC Programme in the interest of Literacy in Arunachal Pradesh in addition to his normal duties.
8. No representation will be accepted for change of posting place.
9. The engaged teacher will have to compulsory undergo an induction training & Orientation programme organized by the Department after his appointment when called for.
10. The employee has to sign an agreement for contract engagement before receiving his engagement order.
11. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
