3. He/she will have to produce a Medical Certificate from an authorised Medical Officer to the effect that he/she is medically fit for the Government service.
4. The appointment is subject to the police verification and he/she will be discharged from the service with immediate effect if there is any adverse remarks against him/her in the Police report.

The other terms and conditions which are not specified herein would be governed by the rules and orders that may be in force from time to time.
