ORDER

In pursuance of Govt. approval vide U.O. No.827 dtd.20/6/2007, the services of Shri Kuber Yadava is hereby regularised temporarily to officiate as Junior Teacher (Language) in the scale of pay of Rs.5500-175-9000/- p.m. plus other allowances as admissible under rules from time to time with effect from 01.05.2007. He/She is posted at Govt. Middle School, Rongte Rite under the DDSE, Koloriang, Kurung Kumey District, Arunachal Pradesh. He is appointed against Md. D. Ahmed, JT (Retired).

- The appointee shall be on probation for a period of 2 (two) years with effect from the date of joining. His/Her continuation in services beyond probation period of 2 (two) years is subject to satisfactory performance during probation period.
- 3. The appointment is subject to the following conditions:-
 - (a) The appointment is purely temporary and may be terminated with 1 (one) month notice. If he/she wants to resign he/she may do so after giving 1 (one) month notice or by surrendering 1 (one) month's salary.
 - (b) The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty
 - (c) After joining duty he/she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
 - (d) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
 - (e) The appointment is subject to the Police Verification and he/she will be dismissed from Govt. service if there is any adverse report against him/her.
 - (f) On joining the appointee shall have to serve for a minimum of 2 (two) years at the place of posting.
 - (g) Seniority of the appointee will be based strictly on merit list in which he/she had been selected for appointment on contract basis.
 - (h) The appointee will not have any claim whatsoever for the services rendered by him/her as a JT(Hindi) contract from the date of their initial appointment till the date of regularization i.e. 01-05.2007. Their regularizations is effected from 1st May,2007.
 - (i) The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting or does not join within 10 (ten) days from the date of issue of this order.

Other terms and conditions of service, which are not specified herein, shall be governed by the relevant rules and order in force from time to time.
