

ORDER

Nang Deepa Manlong is hereby engaged as Assistant Teacher on contract basis up to 31.03.2007 in the fixed pay of Rs. 7200/- (Rs. Seven Thousand Two Hundred) only with effect from the date of Joining in the Govt. Middle School, Kumari Khanti against the centrally sponsored scheme of SSA.

The engagement is subject to the following conditions.

- a. The contract teacher has no right to claim for regular appointment /regularization of the post after expiry of contract period.
- b. No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowance; and any other such allowances.
- c. He/she is not entitled to subscribe GPF / CGEIS or such other schemes during the period of contract service.
- d. The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of Literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration / Education Department in any addition to his /her normal duties.
- e. His/Her application will be accepted for change of posting place.
- f. He/she is to attend the DIT training at concerned DIT for training as and when called for.
- g. All engagements and conditions of services which are not specified shall be governed by the Relevant rules of the Government in force time to time.
- h. The engaged teacher has to sign an agreement for contract engagement before receiving his engagement order.
- i. His contractual service will remain valid only up to 31.03.07 and thereafter it will be treated automatically cancelled and a fresh renewal would be required.
- j. She will have to report for duty at his /her posting place post dated on 01.6.06 failing which his/her engagement order will automatically be treated as cancelled. His /her Pay will be drawn only after getting to my report from the concerned A.P.O (A.E.T / A.D.F.O)
