**ORDER**

No. ED.2/DSE/110/APT/2012: Sri Mita Dodum is hereby appointed temporarily to the post of Trained Graduate Teacher (Business Administration) in the Pay Band-2 of Rs. 9300-34,800 + GP-Rs. 4600/- P.M. and other allowances as admissible under rules from time to time with effect from the date he / she actually reports for duties to the Principal, Govt. Higher Secondary School, Nyapin, Kurung Kumey District, Arunachal Pradesh.

The appointment is made vice Sri Mahesh Pd. Singh, JT promoted to Senior Teacher.

**(2) The appointment is subject to the following conditions:-**

- (i) The appointee shall be on probation for a period of 2(two) years w.e.f. the date of joining and his / her seniority will be fixed as per the over all merit.
- (ii) The appointment is purely on temporary and may be terminated at any time by giving 1(one) month notice without assigning any reason thereof. If he / she wants to resign, he or she may do so after giving 1(one) month notice or by surrendering 1(one) month salary.
- (iii) The regularization of service shall be considered on completion of probationary period subject to satisfactory performance of duty in his/her initial place of posting.
- (iv) After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- (v) He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- (vi) The appointment is Subject to the Police Verification and he / she will dismissed from government service if any adverse report is there with immediate effect.
- (vii) The Trained Graduate Teacher (JTs) who are posted to Higher Secondary School should teach Class XI & XII in their concerned subject till the sanction and posting of Post Graduate Teacher against the said schools.
- (viii) He / she shall remain in the place of posting for a minimum period of 3 (three) years from the date of joining. No representation / campaigning for the change of posting place shall be entertained before completion of 3(three) years of service in the initial place of posting.

Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
