ORDER

In pursuance of Govt. approval vide U.O No .Nil date, 08th October 2012 Shri Simra Cheda Class-XII passed, State Educational worker is hereby promoted temporarily to the post of Asstt. Teacher (A) as per guide line of Educational worker of the State in the Pay scale of Rs. P/B -2-9300-34800+4200/- p.m . plus other allowances as admissible under rules from time to time with effect from the date he/she actually reports for duties at Govt. Pr. School Old Changlang, Under DDSE Changlang District Changlang. He/She is appointed against Shri S.K Chaurasia ,AT(A) Retired.

The Appointment is subjected to the following conditions:-

1. The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he / she wants to resign, he / she may do so after giving one month notice or by surrendering one month salary.
2. The confirmation of service will be considered on completion of probationary period subjected to satisfactory performance of duty.
3. After joining duty he / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
4. The appointment is subjected to Police Verification and he / she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. After joining duty he / she will have to take Oath of an allegiance of affirmation to the Constitution of India in the prescribed form.
6. On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.
7. The seniority of the appointee shall be based strictly on date of joining.
8. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this order at posting place.
9. On their appointment as Assistant Teachers (A) they should undergo compulsory in-service DPE/ B.Ed. within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
