- Their contractual sérvice is purely temperary and can be considered for continuation on the basis
 of performance and approval of salary in subsequent PAB.
- They have no right to claim for regular appointment regularization of the post after expiry of contract engagement.
- They have to submit RCI Registration number to the office of the State Project Director, \$5.4 Rajya.
 Mission, Itanagar within 3 month from the date of consideration of service, facing which their appointment will be treated cancelled.
- The Marksheets / Certificates submitted by them for consideration are subject to verification from
 original source. In case of the forged Marksheets / Certificates they are hable to be punished as per
 CCS Rule.
- 5. No emped leave is permissible except 12 days casual leave as per Central Civil Service leave rule
- During contract service period they are not entitled for medical reimbursement, cluldren educational allowance, reimbursoment of tuition fees, leave based concession (LTC), special compensatory attowance etc.
- The contract resource persons have to report for their duty at posting place within seven days, falling
 which their engagement order will automatically be treated as cancelled.
- 8. They are not entitled to subscribe GPF, CGEIS or such other schemes during the period of contract
- 9. No representation will be accepted for change of posting place
- 10. They will have to undergo for RPs training as and when call for
- 11. The other terms and conditions of service which are not specified shall be governed by the relevant rules and order in forced time to time.
- The engaged Resource Persons have to sign an agreement for contract engagement before receiving this engagement order.
