PROVISIONALLY APPOINTMENT ORDER.
Dated Tawang the 8th Feb'93.

NO: TMD/APT/CON-1/92-93/ Shri Toli Nyedu, is hereby appointed provisionally to officiate as Asstt-Teacher, Grade "A" under the Education Department Govt. of Arunachal Pradesh and posted to Govt. Gyendang Middle school, in the scale of pay of B. 1200-30-1560-EB-40-2040/-P.M. plus other allowances as admissible under the rule from time to time with effect from the date of which he reports for duty in the office of the Deputy Director of Public Instruction, Tawang District, Tawang.

The appointment is subject to the following conditions:-

1. The appointment is purely temporary and may be terminated at any time without assigning any reason after giving thaké one month notice from this end.
2. After joining duty he will have to take an oath of allegiance to the constitution of India duly signed in the prescribed form.
3. He has to produce a medical fitness Certificate from an authorized Medical officer to the effect, he is medically fit for Govt. thaké service.
4. The appointment is subject to the police Verification/ A.P.S.T. Certificate (In case of Arunachal Tribal candidate) and he will be discharged from service with immediate effect if there be any adverse remarks against him in the police report and S.I. Certificate.
5. The appointment is on probation for 2 (Two) years. Their cases for regularisation in the cadre of Asstt. Teacher "A" depends on their performance in duties.
6. Formal appointment thaké order will be issued by Director of Public Instruction, Govt. of Arunachal Pradesh, thaké from the date of joining in the office of the Dy. Director of Public Instruction, Tawang.
7. He is directed to submit two copies of character Certificates from the Casetted officer before joining in service.
