
The appointment are made on the following conditions:

The appointing authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payement to him/ her a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.

3. That the appointees should report to the respective places existing within 30 (thirty) days from the date of issue of this Order. No representation will be entertained regarding change of posting place.
4. No TA/DA shall be permitted for their joining to the place of posting.
5. The other condition of services which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
