

a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month's notice from either side.

b) After joining duty he/she will have to take an oath of allegiance or give affirmation to the Constitution of India duly in the prescribed form.

c) She/he will have to produce a medical certificate from an authorised Medical officer to the effect that he/she is medically fit for the Government service.

4. The appointment is subject to the police verification and he/she will be discharged from service with immediate effect if there will be any adverse remarks against him/her in the police report.
