//ENGAGEMENT ORDER//

MISS HERI SONU is hereby engaged as temporary Guest Faculty (English) purely on hire basis for a period of 06 (Six) months in the consolidated fixed pay of Rs. 25,000/- (Rupees Twenty Five Thousand) only per month with effect from the date of joining in the school, under the Mukhya Mantri Shiksha Kosh (MMSK) for academic session 2022-23. He/She is posted at Govt. Higher Secondary School, Palin

The engagement is made consequent upon his successfully passing the walk-in-interview in pursuance of vide Notification No. ED/KD/DEV-05/MMSK/2022-23, Dated Palin the 2nd September' 2022 against the temporary post of Guest Faculty (English).

The engagement is subject to the following conditions:

1. The temporary Guest Faculty has no right to claim for regular appointment/regularization of the post after expiry of the engagement/agreement period that is 06 (Six) months the agreement shall not be extended beyond 28th February'2023 under any circumstances.
2. No earned leave/maternity leave is permissible except casual leave of 01 (one) day per month as per the Central Civil Service Level rule and as per term and condition mentioned in the agreement copy.
3. During the Temporary Service period, He/She is not entitle for Medical reimbursement, winter Allowances, Children Allowances, Reimbursement of Tuition Fee, Level Travel Concession (LTC), Special Compensatory allowances and any other such allowances.
4. "No Work No Pay" policy will be enforced to the second party. In case He/She is found absent from duty without sanctioned leave. If any breach in discharging duty by the second party, the appointing authority is empowered to discontinue him/her from the temporary service without assigning any reason or prior information.
5. The Temporary Guest Faculty has to report his/her duty at respective posting place within 03 (Three) days from the date of issue of order failing which his/her engagement order will automatically be treated as cancelled. Salary will be prepared/drawn only after receiving intimation from the concerned Head of the Institution regarding his/her joining in the posting place.
6. He/She is not entitle to subscribed to GPF/NPS and CGEIS or such other schemes during the period of Temporary service.
7. No representation will be accepted for change of posting place.
8. The other terms and condition of service which are not specified shall be governed by the relevant Rule/Order/Guidelines/Deed of Agreement/Instruction in force from time to time.
9. Before receiving this engagement order, the engaged Guest Faculty has to sign board Agreement on Non-Judicial stamp paper duly executed by an appointing authority wherein the various terms and condition/ Clauses for hiring them will be clearly stated.
10. The performance of the Guest Faculty thus engaged shall be reviewed periodically in term of the performance of the student taught and if found unsatisfactory, their service shall be discontinue with any prior notice.
