

//ORDER//

Shri/ Smt/ Ms Rajoni Passing is hereby engaged as Junior Teacher on contract basis in the fixed pay of Rs. 26,453/- (Rupees twenty six thousand four hundred fifty three) only with effect from the date of joining in the concerned district upto 31st March 2017 against centrally sponsored scheme of Sarva Shiksha Abhiyan. He/ She posted at Prr./Upper Prr. Govt. P.M. School Moying.

The engagement is made vice resignation/expired/not joined of Sh/Smt/ [Name] Genom Libang JI/AT (SSA). (Applicable in case of resultant vacancies).

The engagement is subjected to the following condition :-

- The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- No earn leave is permissible except casual leave as CCSLR and as per term and condition mentioned in the agreement copy.
- During contract service period he/ she is not entitle for medical reimbursement; winter allowances; children education allowances; re-imbusement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
- The second party shall be entitle for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, bridge course and any the departmental engagement.
- The contract has to report his/ her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his / her engagement order will automatically be treated as cancelled.
- He/ She is not entitle to subscribe GPF or GGEIS or such other scheme during the period of contract services.
- The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/ her normal duties.
- No representation will be accepted for change of posting place.
- He/ She will have to undergone DIET training at concerned DIET for training as and when call for.
- The other terms and condition of services which are not specified shall be governed by the relevant rules and order in force time to time.
- The engaged teacher has to signed an agreement for contract engagement before receiving this engagement order.
