ORDER

The appointment shall be on probation for a period of 2 (two) years w.e.f the date of joining. His/her continuation beyond probation period for 2 (two) year shall be subjected to satisfactory performance during probation period.

The Appointment is subjected to the following conditions :-

1. The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If He/he wants to resign. He/She may do so after giving on month notice or by surrendering on month salary.
2. The confirmation of service will be considered on completion of probationary period subjected to satisfactory performance of duty.
3. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
4. The appointment is subjected to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. After joining duty he/she will have to take Oath an allegiance of affirmation to the Constitution of India in the prescribed form.
6. On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.
7. The seniority of the appointee shall be counted from 29.10.2010 without financial benefit.
8. On their appointment as Assistant Teachers (A) they should undergo compulsory in-service DPE/B.Ed. within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
