ORDER

In pursuance of Govt. approval vide U.O. No. Nil dated 3/3/2008, the service of Miss Mumta Moyong is hereby regularized temporarily to officiate as Assistant Teacher(A) in the scale of pay of Rs.4500-125-7000/- p.m. plus other allowances as admissible under rules from time to time with effect from he/she actually reports for duty to the Principal, Govt. H.S. School, Mahadevpur, Lohit District, Arunachal Pradesh. He/She is posted at Govt. H.S. School, Mahadevpur under disposal of Principal, Govt. H.S.School, Mahadevpur. He/She is appointed against Shri V.P. Tripathi, AT(A) retired.

The appointee shall be on probation for a period of 2 (two) years w.e.f. the date of joining. His/her continuation in service beyond probation periods for 2 (two) years is subject to satisfactory performance during probation period.

The appointment is subject to the following conditions:-

- a) The appointment is purely temporary and will be terminated with 1 (one) month notice. If he/she wants to resign he/she may do so after giving 1 (one) month notice or by surrendering 1(one) month salary.
- b) The continuation of service will be subject to satisfactory performance of duty during probation period.
- c) After joining he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police Verification and he/she will be dismissed from Govt. service if any adverse report is there with immediate effete.

The terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
