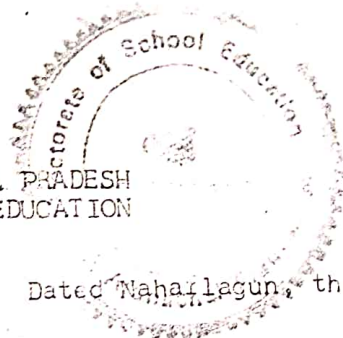

- b) After joining the duty he/she shall have to take on Oath of allegiance of affirmation to the constitution of India in the prescribed form.
- c) He/she will have to produce Medical fitness Certificate in prescribed form from an authorised Medical Officer.
- d) The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.

3. The other terms and condition of services which are not specified here in, shall be governed by the relevant rules and order's in force from time to time.

4. Shri/Smti/Miss Koster Pano shall have to continue for a minimum tenure of 3(three) years term in his present posting place.

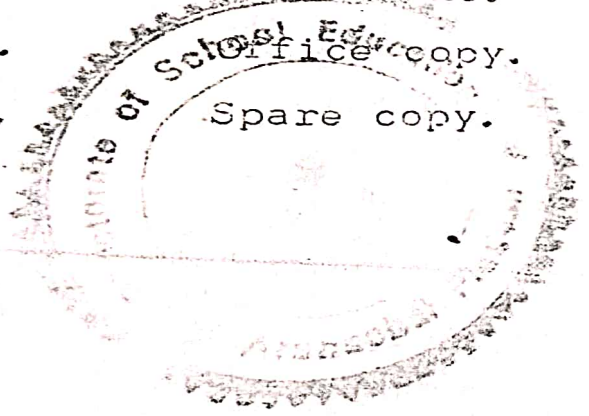
