ORDER

In pursuance of Govt Approval Wide No. U.O No 108 Dated 01/03/2012, Shri. Minsong Mibang is hereby regularized temporarily as Assistant Teacher (A) in the scale of pay PB.2-9300-34800 + GP-4200/ P.M plus other benefits as admissible under rules from time to time with effect from the date he / she actually reports for duty to concerned DDSE. The appointment is made against Shri. Chillo Tubin, AT (A) Promoted to Junior Teacher.

The appointment shall be on probation for a period of 2 (two) years w.e.f. the date of joining. His / Her continuation beyond probation period for 2 (two) year shall be subjected to satisfactory performance during probation period.

The Appointment is subjected to the following conditions:-

1. The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice if he / she wants to resign. He / she may do so after giving one month notice or by surrendering one month salary.
2. The confirmation of service will be considered on completion of probationary period subjected to satisfactory performance of duty.
3. After joining duty he / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
4. The appointment is subjected to Police verification and he / she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. After joining duty he / she will have to take Oath of an allegiance of affirmation to the Constitution of India in the prescribed form.
6. On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.
7. The seniority of the appointee shall be based on the date of joining.
8. The appointment order shall be cancelled if he / she absconds directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this order at posting place.
9. On their appointment as Assistant Teacher (A), they should undergo compulsory in-service DPE / B.Ed within 3 (three) years failing which their appointment order shall be cancelled.


The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
