c) He/She will have to produce medical fitness certificate in
prescribed form from an authorised medical officer.

d) The appointment is subject to Police verification and he/she
will be dismissed from Govt. service if any adverse reports
are there with immediate effect.

relevant rules and order in force from time to time.


