ORDER

The contractual service ~~Sh. Ata Flago~~ Flago is hereby regularized to officiate as Assistant Teacher in Scale of pay of Rs.4500-125-7000-p.m. plus other allowance as admissible under rules from time to time with effect from 08/03/2004. He/she is posted under the disposal of DDSE, Seppa, District, East Kameng, A.P.

The regularization is made Shri Pabo Kino, AT promoted.

2. The incumbent shall be on probation for a period of 2 (two) years with effect from the date 08/03/04. His / her continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

The regularization is subject to the following conditions :-

- a) The regularization is purely temporary and may be terminated at any time without assigning any reasons. If he/she wants to resign he may do so after giving one month's notice or by surrendering one month pay.
- b) After joining the duty he/she shall have to take on Oath of allegiance of affirmation to the constitution of India in the prescribed form.
- c) He/She will have to produce Medical fitness certificate in prescribed form an authorized Medical Officer.
- d) The appointment is subject to Police Verification and he / she will be dismissed from Govt. service if any adverse reports are there with immediate effect.
- e) The other terms and condition of service which are not specified herein, shall be governed by the relevant rules and orders's inforce from time to time.
- f) ~~Sh. Ata~~ Flago shall have to continue for a minimum tenure of 3 (three) years terms in his present posting place.


