- On their regularization as Primary Teacher (AT-A) they should undergo compulsory inservice DIET/DPE/B.Ed. within 3 (three) years failing which their appointment order shall be cancelled.
- The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
