- e) He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- f) The engaged teacher is also to work as volunteer instructor for TLC programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g) No representation will be accepted for change of posting place
- h) He/She will have to under gone DIET training at concern DIET for Training and when call for.
