ORDER.

In pursuance to Govt. Approval vide U.O. No. Nil Dated 9/3/2016 Sri. Rana Dada is hereby regularized temporarily as Trained Graduate Teacher in the scale of pay PB.2-9300-34800 + GP-4600/- P.M. plus other allowances as admissible under rules from time to time with effect of the date he reports for duty to Govt. Primary School, Yangfo under disposal of DDSE, Seppa, East Kameng District. The appointment is made against Sri. Ram Bhorosa Singhal, TGT, retired.

2. The regularization shall be on probation for a period of 2 (two) years w.e.f the date of joining. His continuation beyond probation period for 2 (two) year shall be subject to satisfactorily performance during probation period.

The regularization is subjected to the following conditions:-

1. The regularization is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he/she wants to resign, He/she may do so after giving on month notice or by surrendering on month salary.
2. The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
3. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
4. The regularization is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. After joining duty he/she will have to take Oath an allegiance of affirmation to the Constitution of India in the prescribed form.
6. On joining, the appointee shall have to serve for a minimum period of 3 (three) years at the place of posting.
7. On their regularization as Trained Graduate Teachers he / she should undergo compulsory in-service B.Ed. / D.El.Ed / DPE within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
