APPOINTMENT ORDER

PRT (Prey. Director of School Education against Centrally Sponsored Scheme on SARVA SHIKSHA ABHIYAN.

The engagement is subject to the following conditions:-

- The contract employee has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- During contract service period he/she is not entitled for medical re-imburement; winter allowance; children education allowance; re-imburement of tuition fees; leave travel concession(LTC); Special compensatory allowance etc.
- The Second party shall be entitled for drawl of salary of only for the contract period of one year; salaries for vacation period shall be drawn only when they are engaged departmentally, but subject to availability of fund and approval of the competent authority.
- The contract employee has to report for his/her duty at posting place within 7(Seven) days engagement order will automatically be treated as cancelled. Salary will be drawn only after receiving intimation from the head of the office.
- He / She is not entitled to subscribe GPF of CGEIS or such other schemes during the period of contract services.
- No representation will be accepted for change of posting place.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
- The engaged employee has to sign an agreement for contract engagement before receiving this engagement order.
