1. Appointment in this category may be terminated at any time without assigning any reason other than one stated in the order of appointment.  
2. After joining the post he/she will have to take up duty of a teacher of five periods in the prescribed form.  
3. He/she will have to produce a medical certificate from an authorized Medical Officer in the district that she/he is medically fit for the Government service.

4. The appointment is subject to the police verification and he/she will be discharged from service with immediate effect if there are any adverse remarks against her/his in the police report.
