- 1: The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If He/She wants to resign, He/She may do so after giving one month notice or by surrendering one month salary.
- 2. The confirmation of service will be considered on completion of probationary period subjected to satisfactory performance of duty.

- 4. The appointment is subjected to Police Verification and He/She will be dismissed from service if any adverse report is found against him/her with immediate effect.
