- The appointment is purely on probation for two years and may be terminated at any time without assigning any reason after giving one month's notice from either side.
  - After joining duty he/she will have to take an oath of allegiance and giving affirmation to the constitution of India duly in the prescribed form.
  - She/he will have to produce a Medical certificate from an authorised Medical officer to the effect that she/he is medically fit for the Govt. service.
  - The appointment is subject to the police verification and he/she will be discharged from service with immediate effect if there will be any adverse remarks against him/her in the police report.
  - The other terms and conditions which are not specified here would be governed by the rule and order that may in force from time to time.
