- c) During contract service period he / she is not entitled for medical reimbursement, winter allowances children educational allowance re-imbursement of tuition fees, leave travel concession (LTC). Special compensatory allowance etc.
- d) The Second Party shall be entitled for drawl of salary of only for the contract period of one year salaries for vacation period shall be drawn only when they are engaged departmentally, but subject to availability of fund and approval of the competent authority
