ORDER

Vide DC's approval order No. SD/EDN/SSA/APTT/2016-17 Dtd 14th Feb' 2017 is hereby temporary engaged as a Junior Teacher on contractual basis for six (6) month in the vacant post of Lt. Bitul Darang under SSA in the fixed pay of Rs. 26453/- (Rupees Twenty Six thousand Four hundred Fifty Three) only per month with effect from the date of joining in the office of Dy. Director of School Education against centrally sponsored scheme of Sarva Siksha Abhiyan.

Further, the incumbent extension will be taken up subjected to her performance. The engagement is subject to the following condition.


1. The contract employee has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
2. No earned leave is permissible except Central Civil Service Leave Rule and as per terms condition mention in the agreement copy.
3. During contract service period he/she not entitled for medical reimbursement; winter allowance; children educational allowance; re-imbusement of tuition fees; leave travel concession (LTC); special compensatory allowance etc.
4. The Second Party shall be entitled for drawn only they are engaged departmentally, but subject to availability of fund and approval of the competent authority.
5. The contract employee has to report for his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled. Salary will be drawn only after receiving intimation from the head of the office.
6. She is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
7. No representation will be accepted for change of posting place.
8. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
9. The engaged employee has to sign an agreement for contract engagement before receiving this engagement order.
