- 7. On their appointment as Primary Teacher (AT-A) they should undergo compulsory in-service DIET/DPE/B.Ed. within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the relevant rules in force from time to time.
