2. The officer shall be on probation for a period of 2(two) Years with effect from the date of joining. His/her continuation in service beyond probation period of 2(two) Years is subject to satisfactory performance during probation period.

3. The above appointments are subject to the following terms and conditions :-

- a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month notice from either side. If he/she wants to resign may require to give one month salary.

- b) After joining duty he/she will have to take an oath of allegiance to give affirmation to the constitution of India in the prescribed form.
- c) She/he will have to produce a Medical fitness certificate from an authorised medical officer to the effect that she/he is medically fit for the Government Service.
- d) The appointment is subject to the police verification and he/she will be discharged from service with immediate effect if there by any adverse remarks against him/her in the police report.
- e) He/she will be transferred to Schools any-where in Arunachal Pradesh.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules and order in force from time to time.

The appointment has been made against the resultant vacancy of AT(A).


