fixed pay of 7200/- (Rupees Seven thousand two hundred) only
with effect from the date of joining in the concerned post-
ing place upto 31st March, 2008 against centrally sponsored
scheme of Sarva Shiksha Abhiyan. He/She is posted at Primary/
Middle School, Ranghis.

The engagement is subject to the following conditions:-

- The contract Teachers have no right to claim for regular appointment/regularisation of the post after expiry of contract engagement.
- No earn leave is permissible except casual leaves as per central Civil Service leave rule and as per terms and conditions in the agreement copy.
- During contract service period he/she is not entitled for Medical re-imboursement, Winter Allowances, Children's Educational Allowances, Reimbursement of Tuition Fees, Leave Travel Concession (LTC) Special Compensatory Allowances etc.
- The contract Teachers have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned DDE, failing which his/her engagement order will automatically be treated as cancelled.
- He/she is not entitled to subscribe GPF or CGES or such other schemes during the period of contract services.
- The engaged Teacher is also to work as Volunteer Instructor for TLC Programme for the interest of Literacy in Arunachal Pradesh in addition to his/her normal duties.

- No representation will be accepted for the change of posting place.
- He/she will have to undergo DIET Training at Changlang DIET for training as and when called for.
- The other terms and conditions of the services which are not specified shall be governed by the relevant rules and order in force from time to time.
- The engaged Teacher has to sign an agreement for contract engagement before receiving this engagement order.
