Miss Panem Ngemu is hereby appointed as Junior Teacher on contract basis in the fixed pay Rs. 26,453/- (Rupees Twenty-six Thousand Four Hundred Fifty-three) only with effect from the date of joining in the School against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. She is posted at Govt. Primary School Siddiquah under Vijoynagar Circle.


The appointment is subject to the following conditions:-

- a) The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract appointment.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- c) During contract services period she is not entitle for medical reimbursement, winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowances etc.
- d) The contract teacher shall be entitled for drawal salary of only for the academic session. Salaries for vacant period shall be drawn only when they are engaged in training, Bridge course and any other approved engagement.
- e) The contract teacher have to report her duty at posting place within 7(seven) days from the date of joining in the office of the DDSE, failing which her engagement order will be automatically be treated as cancelled.
- f) She shall not be subscribed GPF or CGEIS or other schemes during the period of contract services.
- g) The contract teacher is also to work as volunteer instructor for TLC programme for the interest of the State of Arunachal Pradesh in addition to his/her normal duties.
- h) The contract teacher will be accepted for changing of posting place.
- i) The contract teacher shall undergo DIET training at DIET Changlang for training as and when call for.
- j) The contract teacher and conditions of services which are not specified shall be governed by the orders in forced time to time.
- k) The contract teacher has to sign an agreement for contract before receiving this engagement
