- f) The engaged teacher is also to work as volunteer instructor of TLC / PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration/ Education Department in any addition to his/her normal duties.
