APPOINTMENT ORDER

The engagement is subject to the following conditions:-

- a) The contract employee has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement; winter allowance; children education allowance; reimbursement of tuition fees; leave travel concession(LTC); Special compensation allowance etc.
- d) The Second hand shall be entitled for draw of salary of only for the contract period of one year; salaries for vacation period shall be drawn only when they are engaged departmentally, but subject to availability of fund and approval of the competent authority.
- e) The contract employee has to report to his/her ODO at posting place within 7(Seven) days engagement order will automatically be treated as cancelled. Salary will be drawn only after receiving intimation from the head of the office.
- f) He / She is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
- g) No representation will be accepted for change of posting place.
- h) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
- i) The engaged employee has to sign an agreement for contract engagement before receiving this engagement order.
