2. (a) The appointment is subject to the following conditions:-

- (a) The Appointment is purely temporary and may be terminated at any time without assigning any reason after giving one months notice from either side.
 - (b) After joining duty he / she will have to take an oath of allegiance of give affirmation to the Constitution of India duly in the prescribed form.
 - (c) He / she will have to produce a medical certificate from an authorised medical officer to the effect that he /she is medically fit for the Govt. Service.

5. A Bond is to be executed by the candidate to the effect that he /she would serve at least for 5 (five) years at his posting place and no transfer would be sought before that until and unless circumstance compels.
