ORDER

Shri/Smti Mumtak Rukhiya is hereby engaged as Assistant Teacher on contract basis under SSA in the fixed pay of Rs. 7,200/- (Repos Seven Thousand Two Hundred/-) only with effect from the date of joining in the concerned district for a period of 1(more) year. He/She is posted to Govt Middle Primary School, Ayengali Town.

The engagement is subjected to the following conditions:-

1. The contract Teacher has no right to claim for regular appointment/regularization of the post after expiry of contract appointment.
2. No earned leave is permissible except causal leave as per Central Civil Service leave Rule as per terms and condition in the agreement copy.
3. During contract service period he/she is not entitle for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession(LTC),special compensatory allowance etc.
4. The contract Teacher have to report his/her duty at posting place within 7(Seven) days from the date of issue of this order for joining in the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
5. He/She is not entitle to subscribe GPF or CGFIS or such other schemes during the period of contract services.
6. The engaged teacher is also to work as volunteer monitor for TLC Programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
7. No representation will be accepted for changes of posting place.
8. He/She will have to undergo DIET training at Govt Hr.Sec.School, Ziro when call for DIET training at Govt Hr.Sec.School,Ziro.
9. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
10. The engaged teacher has to sign an agreement for contract engagement before receiving this appointment order.
