ORDER

Shri/Smti/Miss Dayana Soran, is hereby engaged as PT. (Contract) on contract basis in the fixed pay of Rs. 32,213 /- (Rupees Thirty Two Thousand Two hundred Twenty Three) only with effect from the date of joining in the School against Centrally Sponsored Scheme of Rashtriya Madhyamik Shiksha Abhiyan. He/she is posted at Govt. Secondary/Hr. Secondary School, Pangin Town.

The engagement is made Vide our Advertisement No SD/EDN/RMSA/Tchr Appmt/2013-14/ Dated Pangin the 11th May 2017 against the created vacancy of Govt. Secondary/ Hr. Secondary School Pangin Town.

The engagement is subject to the following conditions:-

- a) The contract employee has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement; winter allowance; children education allowance; reimbursement of tuition fees; leave travel concession(LTC); Special compensatory allowance etc.
- d) The Second party shall be entitled for drawl of salary of only for the contract period of one year; salaries for vacation period shall be drawn only when they are engaged departmentally, but subject to availability of fund and approval of the competent authority.
- e) The contract Teacher has to report for his/her duty at posting place within 7(Seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled. Salary will be drawn only after receiving intimation from the head of the institution.
- f) He / She is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
- g) The engaged teacher is also to work as volunteer instructor for Total Literacy Campaign programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for change of posting place.
- i) Other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
- j) The engaged employee has to sign an agreement for contract engagement before receiving this engagement order.
