ORDER

In pursuance of Govt. approval vide U.O. - After joining He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- The appointment is subject to the Police Verification and He/She will be dismissed from Govt. service if any adverse report is there with immediate effect

The terms and conditions of service which are not specified herein shall be governed by the relevant Rules & Orders in force from time-to-time.
