APPOINTMENT ORDER

SHRI DHAN BAHADUR DARNAL is hereby engaged as TGT (ISSE) Science & Maths Govt. Sec. School Riga under ISSE on contractual basis in the fixed pay of Rs. 20,000/- (Rupees Twenty thousand) only with effect from the date of joining in the office of the Deputy Director of School Education against Centrally Sponsored Scheme of ISSE: SAMAGRA SHIKSHA.

The engagement is made vide the SPD's approval No. AR/ISSE/ESTT/AA/149(SNG)/2020-21/7470-80-14 Dtd. Itanagar the 12th Jan'20 against the vacant post of newly selected TGT (ISSE) Ms Pinky Tali, not join the duty as per order under Siang District, Boleng, Arunachal Pradesh.

The engagement is subject to the following conditions:-

- The contract employee has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- During contract service period he / she is not entitled for medical reimbursement, winter allowances, children educational allowance, re-imbursment of tuition fees, leave travel concession (LTC), Special compensatory allowance etc.
- The Second Party shall be entitled for drawl of salary of only for the contract period of one year, salaries for vacation period shall be drawn only when they are engaged departmentally, but subject to availability of fund and approval of the competent authority.
- The contract employee has to report for his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled. Salary will be drawn only after receiving intimation from the head of the office.
- He/She is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
- No representation will be accepted for change of posting place.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
- The engaged employue has to sign an agreement for contract engagement before receiving this engagement order.


