- c) He/she will have to produce Medical certificate from an authorised medical officer to the effect that he/she is medically fit for Govt. service.
3. The appointment is subject to the police verification and he/she will be discharged from service ~~with~~ immediate effect if there will be any adverse remarks against him/her in the police report.
