**ORDER**

In pursuance of SPD, Itanagar Order NO. AR/SSA/ESTT-1/13 DTD. 3<sup>rd</sup> Oct/2013 Ms Namun Rukbo is hereby appointed as Junior Teacher on contract basis in the fixed pay of Rs. 26,453/- (Rupees Twenty-six Thousand Four Hundred Fifty-three) only with effect from the date of joining in the School against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. She is posted at Govt. Sec. School, Sompoi under Diyun Circle.

**The appointment is subject to the following conditions:-**

- a) The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract appointment.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- c) During contract services period he/she is not entitle for medical reimbursement , winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowances etc.
- d) The Second Party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training , Bridge course and any other department engagement.
- e) The contract teacher have to report her duty at posting place within 7(seven) days from the date of joining in the office of the DDSE, failing which his/her engagement order will be automatically be treated as cancelled.
- f) He/She is not entitle to subscribed GPF or CGEIS or other schemes during the period of contract services.
- g) The appointed teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for changing of posting place.


- i) He/She will have to under gone DIET training at DIET Changlang for training as and when call for.
- j) The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in forced time to time.
- k) The appointed teacher has to sign an agreement for contract before receiving this engagement order.
