- The contract teacher have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned D/S, failing which his/her engagement order will automatically be treated as cancelled.
- He/she is not entitled to subscribed CIP or CCPS or such other schemes during the period of contract services.
- The engaged teacher is also to work as volunteer instructor for T.C programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- No representation will be accepted for change of posting place.
- He/She will have to under gone DICT training at concern DICT for Training and when call for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force at the time.
