The engagement is subject to the following conditions:

- The contract teacher has no right to claim for regular appointment regularization of the post after expiry of contract engagement.
- No earned leave is permissible except annual leave as per Central Civil Service Leave Rule and as per terminating condition mentioned in the agreement copy.
- During contract service period he/she is not entitled for medical reimbursement, winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession(L.T.C), special compensatory allowance etc.
- The contract teacher have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned DSEB, failing which his/her engagement order will automatically be treated as cancelled.
- He/she is not entitled to subscribe CIPR or CIPRS or such other schemes during the period of contract services.
- The engaged teacher is also to work as volunteer instructor for U.LC programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- No representation will be accepted for change of posting place.
- He/She will have to undergo DSET training at concerned DSET for Training and when called for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force upto 10 times.
- The engaged teacher has to sign an agreement for contract engagement before receiving the engagement order.
