Sir/Madam,

As per the recommendation of the Selection Committee, you Monni Pertin have been offered the post of Assistant Teacher grade "A" purely on temporary basis in the scale of pay of Rs.1200-30-1560-EB-40-2040/- per month plus other allowances as admissible under rules from time to time against the post created vide Govt. order NO.ED-2/192/77 Pt. dated 11/10/79 and has been posted to Govt. I. V. School, Mipi. If you accept the offer of appointment, you should join immediately in the school as indicated above and forward the Joining Report alongwith other relevant documents to the Deputy Director of Public Instruction, Dibang Valley District, Anini through the respective Administrative officers. The offer of appointment shall remain valid upto 20th Sept/90. If you fail to join on or before the stipulated date, your offer of appointment shall be treated as withdrawn and a new candidate from the panel shall be appointed against the vacant post.

The offer is subject to the following conditions:-

- 1) i. The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month notice from either side.
 - ii. After joining duty you will have to take an Oath of allegiance of affirmation to the constitution of India in front of a Gazatted officer in prescribed form.
 - iii. You will have to produce a Medical Certificate from an authorised Medical Officer to the effect that you are medically fit for the Govt. services.
- 2) The appointment is subject to Police Verification and you will be discharged from service with immediate effect, if there be any adverse remarks against you in the Police Report.


- 3) The other terms and conditions which are not specified here would be governed by the rules and orders that may be enforce from time to time.
