// APPOINTMENT ORDER //

Shri/Smt. TECHI AKOP is hereby engaged as Upper Pry. Teacher (TGT) Science/Mathematics/Social Science/Language(English/Hindi)/Primary Teacher (PRT) on contract basis in the fixed pay of 21,175.00 Rupees Twenty One thousand One Hundred Seventy Five only with effect from 01/05/2018 in Namsai district up to one year against centrally sponsored scheme of SARVA SIKSHA ABHIYAN. He/She is posted at Govt. Sec. School Alubari.

The Engagement is subject to the following conditions:-

1. The contract Teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
2. No earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and conditions mentioned in the agreement copy.
3. During contract service period he/she is not entitled for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
4. The contract employee have to report his/her duty at posting within 7(seven) days from the date of joining in the concerned DDSE's office failing which his/her engagement order will automatically be treated as cancelled.
5. He she is not entitled to subscribe GPF/CGEIS or such other schemes during the period of contract services.
6. The engaged employee is also to work as volunteer instructor of TLC/PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./Dist. Administrator/Education Department in any addition to his/her normal duties.
7. No representation will be accepted for change of posting place.
8. The other terms and conditions of service which are not specified shall be governed by the relevant rules/orders/guidelines/instruction in force time to time.
9. The engaged Teachers has to sign an agreement for contract agreement before receiving this engagement order.
10. His/ Her contractual service will remain valid for 1 (one) year and thereafter it will be treated automatically terminated and a fresh renewal will be required.
