He is directed to report to the school for duty after completion of induction training in DIET, Naharlagan. The duty joining report should route through the Headmaster/ Teacher in charge of the school.


No request for change of posting place will be considered. Other terms and conditions not specified here in shall be governed by the relevant rules and orders from time to time.






