The other terms and conditions of service which are not specified herein shall be governed by the relevant rules and order in force from time to time.



The promotion is made subject to the following conditions: -


1. The promotion is purely temporary and may be reverted to his original post of A/T (A) at any time without assigning any reason thereof.
