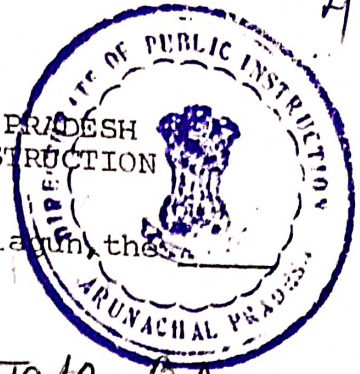

2. The Officer shall be on probation for a period of 2(two) years with effect from the date of joining. His/her continuation in service beyond probation period of two years is subject to satisfactory performance during probation period.

3. The appointment is subject to the following conditions :-

- The appointment is purely temporary and may be terminated at any time without assigning any reasons after serving one months notice. It he/she wants to resign may require to give one months notice or surrender one months salary.
- After joining in the duty he/she shall have to take oath of allegiance of affirmation to the constitution of India in the prescribed form.
- He/she will have to produce medical fitness certificate in prescribed form from an authorised medical Officer.
- The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.

4. The other terms and conditions of Service which are not specified herein shall be governed by the relevant rules and order in force from time to time.

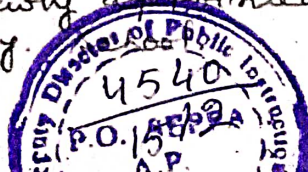



In compliance with order of Hon'ble Gauhati Court Itanagar Permanent Bench Naharlugan dated 10.02.2016 in WP(C)No.447(AP) 2015 and In the interest of public service, the Governor of Arunachal Pradesh is pleased to regularise Shri Sangkoli Taffo, BEO permanently to the post of Block Education Officer (BEO) against existing vacancy in the Pay Band of Rs.44900-142400 at level-7 of the Pay Matrix Group-B Gazette (Non-Ministerial) plus other allowances as admissible under rules from time to time with immediate effect under following terms and conditions:-

1. The final seniority of the Officer in the cadre of Block Education Officer shall be fixed as per the seniority rules.
2. Consequent upon his regularisation in the post of Block Education Officer, Shri Sangkoli Taffo shall have to willingness letter that he shall not have any claim in the cadre of Trained Graduate Teacher on his regularisation as Block Education Officer.
