2. The appointment is subject to the following conditions:-

a) The appointment is purely temporarily and may be terminated at any time without assigning any reason after giving one months notice from either side.

b) After joining duty he/she will have to take an oath of allegiance or give affirmation to the Constitution of India duly in the prescribed form.

c) He/she will have to produce a Medical Certificate from an authorised Medical Officer to the effect that he/she is medical. fit for the Government Service.

3. The appointment is subject to the police verification and he/she will be discharged from service with immediate effect if there be any adverse remarks against him/her in the police report.

The other terms and conditions which are not specified here would be governed by the rule and order that may be in force from time to time.
