2. The appointment is subject to the following conditions :-

- a) The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month's notice from either side.
- b) After joining duty they shall have to take an oath of allegiance or give affirmation to the Constitution of India duly in the prescribed form.
- c) They shall have to produce Medical Certificate from the authorised Medical Officer to the effect that they are medically fit for Government service.

3. The appointment is subject to the Police Verification and they shall be discharged from service with immediate effect if there be any adverse remarks against them in the police reports. The other terms and conditions which are not specified here would be governed by the rule and order that may inforce from time to time.


