ORDER.

In pursuance of Govt. approval vide U.O No. 304 dated 17/11/05 Shri Kacha Tajo is here appointed temporarily to officiate as Assistant Teacher (A) in the scale of pay of Rs. 4500-125-7000/- p.m. plus other allowances as admissible under rules from time to time with effect from he / she actually reports for duty at Govt. Pry. School, Tajo disposal of DDSE, Seppa, East Kameng District Arunachal Pradesh.

2. The appointment is made vice Smti Aroti Gao, AT (Promoted).
3. The appointee shall be on probation for a period of 2(two) years with effect from the date of joining. His / her continuation in services beyond probation period of 2(two) years is subject to satisfactory performance during probation period.
3. The appointment is subject to the following conditions:-
  - a) The appointment is purely temporary and may be terminated with 1(one) month notice. If he / she want to resign she may do so after giving 1(one) month's notice or by surrendering 1(one) month salary.
  - b) The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
  - c) After joining duty he / she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
  - d) He / she will have to produce Medical fitness Certificate from an authorized Medical Officer.
  - e) The appointment is subject to the Police Verification and he/ she will be dismissed from Govt. service if there is any adverse report from the Police.
  - f) On joining the appointee shall have to serve for a minimum of five years at the place of posting.
  - g) The appointment order shall be cancelled, if the appointee directly or in-directly campaigns for change of place of posting or does not join within 10(ten) days from the date of issue of this order.

Other terms and conditions of service, which are not specified herein shall be governed by the relevant rules and order in force from time to time.

[2] The terms and conditions of promotion are as follows: -

1. The promotion is purely temporarily and may be reverted to his/ her original post of Primary Teacher after serving 1 (one) month notice in case if any given or information furnished by the teacher proves to be false and if the teacher is found to have wilfully suppressed any material fact, he/ she will be liable to be removed from service/ discharged from probation and such other action may be taken by the Govt. as deem fit.
2. His/ Her continuation in the post is subject to satisfactory performance during probation for a period of 2 (two) years from the date of joining in the posted school.
3. The promotee carries with the liabilities to serve in any Govt. Secondary/ Higher Secondary School of Arunachal Pradesh.
4. The promotee shall join the school within 15 (fifteen) days failing which his/ her promotion order shall automatically stand cancelled.
5. Their seniority will be counted from the date of joining his/ her duty at School where he/ she has been posted.
6. No representation regarding change of place of posting will be entertained in any circumstances.
7. The other terms and conditions which are not specified herein shall be governed as per existing Government Rules and Orders in force from time to time.


